### Dear all,

AFL Queensland is pleased to publish and circulate the 2025 AFL Queensland Community Rules and Procedures (Rules) which can be found **attached**.

This document should be read in conjunction with the <u>Laws of Australian Football</u> and the <u>National Community</u> <u>Football Policy Handbook</u>.

AFL Queensland reviews the Rules annually, striving to continually streamline the document. With the implementation of the National Community Football Policy Handbook in 2022, and the merging of the AFL Queensland Senior and Junior Competition Rules and Regulations in 2023, a significant review of the current document has been conducted to ensure that our Rules, in line with the Handbook, are as user friendly as possible for our community stakeholders.

As a result, there has been significant change to the wording, layout and sections of the new document. However, fundamental changes to the Rules and interpretations themselves have been kept to a minimum, with an overview of the key changes outlined below.

Whilst we have made efforts to highlight all major changes, it is the responsibility of clubs to familiarise themselves with the updated Rules.
